Legal basis for the processing of personal data - Article 6 (1). letter (a) GDPR - the person concerned has consented to the processing of his / her personal data for at least one specific purpose.

Retention period of personal data - ten years.

The person concerned hereby declares that they give the operator his explicit and unreserved consent to the processing of his personal data to the above extent, for the stated purpose and for the aforementioned time period.

The person concerned is obliged to provide true and up-to-date personal data. In case of a change of personal data, the person concerned is obliged to notify the data manipulator of the change without delay.

The person concerned has the right to withdraw his consent at any time. The withdrawal of consent does not affect the legality of the processing based on consent prior to its withdrawal.

The rights of the person concerned are defined in Chapter 3 of the GDPR. The rights are: the right to require from the manipulator the access to the personal data relating to the person concerned, the right to rectify them or to delete them; the right to the limitation of processing or the right to object to the processing, as well as the rights to data portability and the right to lodge a complaint with the supervisory authority
